Message from our pharmacist – Ekta

Please be aware of the new regulatory measures regarding Valproate

From January 2024:

- Valproate must not be started in new patients (male or female) younger than 55 years, unless two specialists independently consider and document that there is no other effective or tolerated treatment, or there are compelling reasons that the reproductive risks do not apply.
- At their next annual specialist review, women of childbearing potential and girls should be reviewed using a revised valproate Risk Acknowledgement Form, which will include the need for a second specialist signature if the patient is to continue with valproate and subsequent annual reviews with one specialist unless the patient's situation changes.

Acute Medicine as a speciality and as a community has grown in its stature and influence within healthcare since I was last on SAM Council as Trainee Representative in 2016 and I am looking forward to building on the strong organisational foundations set by my predecessors in this role.

These are challenging times for the NHS in a high demand and under-resourced system. Acute Medicine has established its role as an innovator in the urgent care both at the front door, stretching into rapid diagnostics and Hospital at Home systems.

This innovation is fostered by engagement and growing community of practice of the Acute Medicine speciality. Over the last few years, I have been working with a couple of organisations on growing membership, engaging members to take more active roles, and facilitating collaborative projects.

For SAM, I have been co-chairing the Acute Oncology sub-group over the past year, where we have established a close relation with the Acute Oncology Society resulting in a few publications, conferences, and creating a growing community for those of us with a sub-specialist interest in Acute Oncology. The Whatsapp based Acute Medicine Trainee & New Consultant (1st 5 years post CCT) has continued to grow since it was founded in 2015 from initially 10 regional representative members to more than 180 members across the UK facilitating an informal support and advice network across regional boundaries on both training and the practice of Acute Medicine.
