SAMBelfast POCUS

Are you interested in POCUS? Do you have a game-changing case? Do you want the opportunity to present it in Belfast?!

SAMBelfast includes a POCUS cases lightning session, where we are aiming to showcase the utility of point of care ultrasound within Acute Medicine. If you have an **anonymised** case (with good quality images) that you'd like to present, applications will open soon!

Applications will require a brief (<200 words) abstract outlining the case, the POCUS intervention and why it was memorable. These will be adjudicated and successful authors invited to come and present the case in Belfast.

- 10 minute speaking session (can include brief evidence outline / teaching points if appropriate)
- Maximum 200 word abstract
- Must have good quality **anonymised** images of the case available
- All clinicians involved in Acute Medicine eligible to apply (non-Consultant grades encouraged)
- Successful speakers will receive 2 day conference attendance. Please note travel and accommodation will not be provided for speakers in this session

Applications will open in early February and we will be in touch then to share information with where to apply.

Important updates from this month (with thanks to Dr De Wolff)

• The NCEPOD report into community acquired pneumonia "consolidation required"

Good review of this very common condition. A timely reminder for us to think about it in those who present with confusion (17.7% of those with CAP had confusion) and 11.5% had no typical features of CAP. 68.6% had a cough, 56.3% had SOB and 30.6% had fever.

We are not giving antibiotics within 4 hours in 27.5% of patients. Only 33% got written information on CAP, this is important as patients will often represent if the course of the disease is not properly explained. We are inconsistent on arranging a repeat chest x-ray (advised for >50 and current or ex smokers). 51.7% had a CXR requested but 19% of these did not get it done.

• NICE: The updated <u>epilepsies in children, young people and adults quality</u> <u>standard</u> (QS211) has been published

6 statements about the standard of care for these patients. The 2 week rule for patients seen after a first suspected seizure is still there and 4 week rule for patients referred to tertiary epilepsy service (2 weeks if urgent).

The 2 new statements for 2023 are;

<u>Statement 5</u> People with epilepsy are asked about their memory, mental health, and social and emotional wellbeing at epilepsy appointments. **[new 2023]**

<u>Statement 6</u> Children and young people with epilepsy are asked at epilepsy appointments about neurodevelopment and learning difficulties or changes in their learning progress, and

adults who have learning disabilities are asked at epilepsy appointments about changes in their condition and other comorbidities. **[new 2023**

- A recent interesting debate in the Emergency Medicine Journal (https://emj.bmj.com/content/41/1/4) as to whether "acute behavioural disturbance" is a distinct clinical entity or whether it should be considered a form of severe agitation. This is highly relevant in acute medicine, especially where the cause of the symptoms is unclear and of possible organic aetiology. (Every AMU gets these patients occasionally, and they cause much stress and often damage.)
- Did you catch the December webinar regarding last year's important updates? (https://www.acutemedicine.org.uk/blog/learning-hub/society-for-acute-medicine-educational-evening-18-december-2023-2023-a-year-in-review/)

We reviewed relevant NICE guidelines and also one of the big publications this year – The BTS guidelines on Pleural disease. (https://www.brit-thoracic.org.uk/quality-improvement/guidelines/pleural-disease/), issued in July. One major change is that primary spontaneous pneumothorax does not require drainage if there are minimal symptoms, even if it is "large" by conventional criteria.

Another interesting article relevant to us from 2022, but it contains useful guidance on how to titrate heart failure medications in the face of worsening renal function (WRF). https://onlinelibrary.wiley.com/doi/10.1002/ejhf.2471

Highlights - creatinine could be allowed to rise as high as 50% from baseline (as long as eGFR remains >25ml/min, creatinine <265.2 and potassium doesn't rise).



20 & 27 February, 5 & 13 March 2024 Zoom webinars
